Dear Colleagues,

On April 1, 2025, Snohomish County Health Department confirmed a new case of measles, most likely associated with international travel. This is the third case of measles in Washington this year. This case is not linked to the two previous cases identified in late February and March. Please find a joint media release issued by Snohomish County Health Department and Public Health – Seattle and King County [linked here](#).

The public exposure locations listed below have been identified. Secondary cases would be expected to occur between 4/03/2025 and 4/21/2025.
